C. 24 (BILL C-92) BACKGROUND:

The Keewatin Tribal Council Bill C-92 Project received initial funding from ISC, Community Well-Being and Jurisdictions Initiative program. Funding was designated for Bill C-92 community engagement project in 6 of the 11 KTC communities. The 6 participating communities are as follows:

- Fox Lake Cree Nation
- Mantou Sakahigan First Nation
- Manto Sipi First Nation
- Sayisi Dene First Nation
- War Lake First Nation
- York Factory First Nation

The following 5 communities chose to seek independent Bill C-92 funding. These 5 communities are welcome to join the KTC Bill C-92 project at any time and will continue to be invited to participate in the projects activities and events.

FUNDING

The KTC C. 24 (Bill C-92) Project receives funding from:

Community Well-Being and Jurisdiction Initiative (CWJI) Program

The Community Well-Being and Jurisdiction Initiatives Program provides funding to First Nation communities to lead, develop and deliver prevention programs and services that:

- are culturally appropriate
- are in keeping with the best interests of the child, as determined by the community
- support First Nations capacity in child and family well-being

The program enables multi-year projects that:

- expand the availability of prevention and well-being initiatives responsive to community needs
- complement prevention programming provided by First Nations Child and Family Services agencies or provincial and territorial agencies
- increase capacity of child and family services prevention programming
- support First Nations in developing and implementing jurisdictional models.

2021-2022 Funding

December 2020 – KTC received notification from ISC CWJI that the collaborative community KTC C. 24 (Bill C-92) project will receive \$2,000,000 for the 2020-2021 fiscal year.

2022-2023 Funding

The project did not receive any additional funds for this fiscal year as engagement events/activities began towards the end of the fiscal year. Therefore, the majority of the budget from the 2020-2021 fiscal year remained.

2023-2024 Funding

March 2024 – KTC received funding for the collaborative community KTC C. 24 (Bill C-92) project of 1.2 million. The funding decreased due to 1 of the original 7 communities requesting independent funding in 2023.

2024-2025 Funding

End of year report and financial being prepared for submission to Indigenous Services Canada.

HUMAN RESOURCES

Keewatin Tribal Council requires staff to guide and assist in the development and ratification of an Indigenous Child and Family Services law and regulations, including the development of an Indigenous Governing Body for Child and Family Services within our region. C. 24 (Bill C-92) Project Staff will work as a team to ensure that engagement activities occur with all Nations and relevant information is collected that will assist in the creation of new law and regulations.

STEERING COMMITTEE/ELDERS ADVISORY

The KTC CFS Steering Committee is comprised of a representative from each of the participating Nations. Committee Members were appointed by the Chief and Council of their respective Nation and is made primarily up of Councillor's holding the CFS portfolio. The Committee meets once per month for 2-3 days and meetings are planned 6 months in advance.

The purpose of the Steering Committee is to assist in the development of child and family services based on the vision, needs, customs, traditions, and values of Member Nations of Keewatin Tribal Council within the framework of self-determination.

Specific Areas of Responsibility

The Steering Committee will perform the following key duties:

- Attend and participate in all scheduled meetings.
- Prepare for meetings.
- Respectful code of conduct as per Keewatin Tribal Council policy, including toward other Steering Committee members, Chief and Council, legal counsel, and citizens.
- Work with the legal team to develop a Keewatin Tribal Council CFS Law for recommendation to the Keewatin Tribal Council Leadership.
- Engage in and participate in meetings with citizens of Member Nations.

- Provide regular updates to the Keewatin Tribal Council Leadership.
- Additional duties as may be delegated to the Committee by the Keewatin Tribal Council Leadership, as per April 22, 2021, Resolution:
 - Develop a child and family services law;
 - o Determine the scope of the child and family services law;
 - Determine how services will be delivered and by whom;
 - Authorize an Indigenous governing body to act on behalf of the Keewatin Tribal Council children, youth, and families; and
 - Confirm the mandate of the Indigenous Governing Body.

Presented/discussed the importance of language preservation and encouraging Nations to begin with and use the language in the creation of their law.

Presented/discussed the Dene language and the intricacies of translating the English language to Sayisi Dene syllabics.

Flora Beardy, Ininew Interpreter/Translator – York Factory Cree Nation

Presented/discussed the Ininew language and the intricacies of translating the English language to Ininew, outlining the descriptive nature of the Ininew language.

Don Robinson, B.S.W., M.S.W

Originally from Bunibonibee (Oxford House) First Nation, is a graduate from the University of Manitoba with a Bachelor of Social Work (1991) and a Master of Social Work (2001). He has over 38 years of experience in the helping field and as a therapist in Private Practice. He has worked extensively in the homelessness serving sector with the At Home Chez Soi Housing First initiative. He has travelled extensively throughout Manitoba and across Canada delivering professional development training and healing workshops.

He brings a unique cultural perspective on healing, intergeneration trauma, cross cultural awareness, family therapy with Indigenous families, training and learning, traditional ways of healing, and family group conferencing. He has learned from Elders and knowledge keepers about the traditional ways through participating in ceremonies, fasting, sweat lodge, and the Sundance.

Ivana Yellowback

Ivana Yellowback is a member of Manto Sipi Cree Nation (God's River), and a relative to Mathias Colomb Cree Nation (Pukatawagan - paternal family). She is both Asiniskow Ithinew ekwa Muskego Ininew (High Rock and Muskeg Cree).

Ivana is an Associate Producer, Writer, Cree host, and English co-host of Eagle Vision's and APTN's 7TH GEN <u>Home (7thgen.ca)</u> \ <u>Cree Webisodes</u> | <u>7TH GEN</u> (2022/2023/2024). She has also acted as principal characters in "DJ Burnt Bannock" (2021) <u>The Team — DJ Burnt Bannock</u>, along with "Little Bird" (2023) <u>'Little Bird,' From Fremantle, Rezolution: Jennifer Podemski Talks - Variety</u>.

Ivana holds a 4-year Bachelor of Arts HONOURS degree at the University of Winnipeg (Sociology, Minor: Conflict Resolution Studies), and a Bachelor of Social Work degree at the University of Manitoba. Ivana is working on her Masters of Social Work at the University of Manitoba.

Ivana holds 10+ years of experience in social services work, spanning from program development and implementation, facilitation, and workshop trainings (various), youth mentorship and leadership, and social advocacy and counselling.

Ivana is an Executive Training Facilitator (with Indigenous Leadership Development Institute Inc.), an executive board member for sakihiwe festival, and is an **oskâpêwiskwew** (helper) member of the Indigenous Helpers Society. She is also a trained Traditional Family Parenting facilitator, a Grief and Loss Facilitator, and Indigenous Life Skills Coach. Ivana's most important roles and work is being an aunty, pipe carrier, lodge carrier, drum carrier and singer.

PHASED PROJECT PLAN - 2022-2025

Phase One – Foundational/Technical (6 months)

• Initial project activities – staffing, contacts/connections, information sharing, legal process, etc.

Phase Two – Implementation/Engagement (6-18 months)

 Getting to know the communities – Steering Committee member recruitment, first Conference with all Nations, individual Nation engagements, etc.

Phase Three – Monitoring/Engagement (18-36 months)

- We are now working in the end of phase 3.
- Draft Law created and intensive review/revision of the draft is now taking place – English version
 - Law versions planned upon completion
 - 1. English version with Ininew language terms
 - 2. English version with Denesuline language terms
 - 3. Ininew language version
 - 4. Denesuline language version
 - 5. Potential individual Nation language versions
- Continued work on Policy, Regulations and Service Delivery models.
- Working towards presentation of draft law to leadership.

- July/August 2024 Tentative Leadership Summit
- August 2024-March 2025 presentation of law in each individual KTC Nation.
- March 2025 Send Notice to Federal and Provincial Government to begin Coordination Agreement Process

Phase Four – Ratification/Implementation (36+ months)

- 2025-2027
- Ratification of the Law within each Nation.
- Collective ratification ceremony with all 6 Nations.
- Implementation of the Law service delivery.

- Ongoing individual engagement sessions to inform, engage community members in Law development process.
